## Additional Information

### **How to make public comment:**

Want to comment on an item either at a work session and general meeting and not sure how to?

No worries for the work session we do not typically accept public comment but you can send an email to [clerk@gustavus-ak.gov](mailto:clerk@gustavus-ak.gov) or drop off a hand written letter (there is a mail box outside the office door) and ask for it to be shared with the City Council Members.

During a general meeting if you would like to comment on an item not on the agenda you will have two opportunities to speak once near the start of the meeting and once near the end. The item on the agenda is called "Public comment on non-agenda items".

If the item is on the agenda, you will have a chance to comment on the item once there has been a motion and a second on the item. There is typically a summary provided then it's open for public comment. If the agenda item is up for public hearing, then the item will have a summary provided and public hearing will be opened on the item, this is when you would speak. The only other caveat to that would be if there is a motion to postpone an item then there will not be public comment on it. In that case you can still send an email or letter on the topic to the clerk to share with the council.
