CITY OF GUSTAVUS, ALASKA Resolution 2011-22

A RESOLUTION CERTIFYING THAT THE MUNICIPALITY DID SUFFER SIGNIFICANT EFFECTS DURING THE PROGRAM BASE YEAR FROM FISHERIES BUSINESS ACTIVITIES THAT OCCURRED WITHIN THE NORTHERN SOUTHEAST FISHERIES MANAGEMENT AREA

WHEREAS, as 29.60.450 requires that for a municipality to participate in the FY12 Shared Fisheries Business Tax Program, the municipality must demonstrate to the Department of Commerce, Community, and Economic Development that the municipality suffered significant effects during calendar year 2010 from fisheries business activities; and,

WHEREAS, 3AAC 134.060 provides for the allocation of available program funding to eligible municipalities located within fisheries management areas specified by the Department of Commerce, Community, and Economic Development; and,

WHEREAS, the City of Gustavus is located within a fisheries management area with an allocation less than the long-form threshold value, and

WHEREAS, 3 AAC 134.120 provides that this resolution satisfies the Short-Form Application resolution requirements under the FY12 Shared Fisheries Business Tax Program, and

NOW THEREFORE BE IT RESOLVED that the City of Gustavus City Council by this resolution certifies that the City of Gustavus did suffer significant effects during calendar year 2010 from fisheries business activities that occurred within the Northern Southeast Fisheries Management Area and wishes to apply for funding under the FY12 Shared Fisheries Business Tax Program.

AN ORDINANCE FOR THE CITY OF GUSTAVUS PROVIDING FOR THE AMENDMENT OF LIBRARY BUDGET FOR FISCAL YEAR 2012

BE IT ENACTED BY THE GUSTAVUS CITY COUNCIL AS FOLLOWS:

- Section 1. Classification. This is a Non-Code Ordinance
- **Section 2.** For the Fiscal Year of 2012, estimated expenditures have changed from the estimates in the approved budget.
- **Section 3.** For the current fiscal year the budget is amended to reflect the changed estimates as follows:

CITY OF GUSTAVUS, ALASKA Resolution 2011-23

A Resolution Providing for a Cost-of-Living Pay Adjustment for City of Gustavus Employees in Regular Positions

WHEREAS, the City Council of the City of Gustavus adopted an "Employee Payment and Earnings Policy" on June 8, 2006, and

WHEREAS, the section of that "Employee Payment and Earnings Policy" entitled "Pay Raises" requires the City to make annual pay adjustments irrespective of ongoing changes in the local, state or national economy, without recognition of the City's ability to afford the annual adjustments, and without any other consideration of the best interest of the City, its citizens or the City's employees, and

WHEREAS, the section of that "Employee Payment and Earnings Policy" entitled "Pay Raises" specifies a range of adjustments that may or may not be relevant to any given situation or without providing any mechanism or guidelines for applying the specified increments, and

WHEREAS, the City Council of the City of Gustavus therefore desires to amend the section of the City's "Employee Payment and Earnings Policy" entitled "Pay Raises" to address those issues, and

WHEREAS, the City Council of the City of Gustavus desires to grant pay adjustments to all employees in a Regular Position, defined, for the purposes of this pay adjustment, as: a full-time or a part-time year-around position in which the employee generally works the same schedule every week, although actual hours each week may vary with season or with work load, and

WHEREAS, the City Council of the City of Gustavus has determined that adjusting the pay of its Regular Position employees in an amount equal to the change in the consumer price index (CPI) for Anchorage is appropriate at this time, and

WHEREAS, the consumer price index (CPI) for Anchorage, the standard measure of CPI for Alaska, rose 2.8% during FY2011.

NOW THEREFORE BE IT RESOLVED, by the City Council of the City of Gustavus as follows:

(1) The section of the City's "Employee Payment and Earnings Policy" entitled "Pay Raises" is hereby amended to read as follows:

Periodic Pay Adjustments

The City Council may grant, from time to time, by resolution, periodic adjustments to the City's pay schedule. The City Council will consider the cumulative change in the Consumer Price Index (Anchorage) since the last such pay adjustment in formulating such adjustments. Such periodic pay adjustments, if any, will apply to all Regular Position employees of the City of Gustavus. A Regular Position is a full-time or part-time year-around position in which the employee generally works the same schedule every week, although actual hours each week may vary with season or with work load.

- (2) The following are Regular Position employees of the City of Gustavus: Fire Chief, City Clerk, DRC Manager/Operator, and Librarians.
- (3) The Gustavus City Council grants a 2.8% cost-of-living pay adjustment to current hourly rates (nonexempt) and base salary (exempt) for employees identified in section 2 of this Resolution effective November 1, 2011.
