# AN ORDINANCE FOR THE CITY OF GUSTAVUS ADOPTING AN AMENDMENT TO TITLE 2.03.030(a) Regular (General) Council Meetings.

#### BE IT ENACTED BY THE GUSTAVUS CITY COUNCIL AS FOLLOWS:

- **Section 1. Classification** This ordinance is of general and permanent nature and shall become a part of the City of Gustavus Municipal Code.
- **Section 2. Severability** If any section or subsection of this title is determined to be illegal or unenforceable, the remaining provisions shall not be affected, but remain valid and enforceable to the extent permitted by law.
- **Section 3. Enactment** Now therefore, be it enacted by the Gustavus City Council that Title 2 be amended as follows: **Bolded** items are additions, strikethroughs are deletions.

#### TITLE 2

#### Section 2.30.030 Regular (General) Council Meetings

Date Introduced: October 17, 2013

(a) The City Council shall meet for a regular meeting at 7:00 p.m. on the second **Monday** Thursday of each month. If a regular City Council meeting so scheduled is to take place on a holiday established by Alaska Statute 44.12.010, that meeting shall be rescheduled to take place at 7:00 p.m. on the third **Monday** Thursday of that month. If both the second and third **Mondays** Thursdays of a month are holidays (as defined above), the regular City Council meeting shall be rescheduled to 7:00 p.m. on the fourth **Monday** Thursday of that month. If the City Council regular October meeting is the first regular meeting after the results of a General Election have been certified, that meeting shall be held at 7:00 p.m. on the third **Monday** Thursday of October. The City Council may by motion or otherwise change the date of a meeting as may be necessary or convenient.
