**A RESOLUTION OF THE CITY COUNCIL OF GUSTAVUS, ALASKA
AUTHORIZING SUBMISSION OF A PETITION TO THE ALASKA LOCAL
BOUNDARY COMMISSION FOR ANNEXATION OF TERRITORY TO
THE CITY OF GUSTAVUS**

WHEREAS, the Borough Committee was directed by the Gustavus City Council (Resolution # 2008-23) in December, 2008 to develop a petition and supporting documents for submission to the State of Alaska Local Boundary Commission for the annexation of lands in the Falls Creek area and waters of Icy Passage between Gustavus and Pleasant Island; and

WHEREAS, the Borough Committee and its local government consultant have completed the draft Petition and Petitioner Brief; and

WHEREAS, the submission of a petition to the State of Alaska Local Boundary Commission begins a formal process of review of the petition and associated public hearings; and

AND NOW THEREFORE BE IT RESOLVED, by the Gustavus City Council as follows:

Section 1. Authorization. That the Mayor of the City of Gustavus is authorized to file the Petition and Petitioner Brief for annexation by legislative review with the Alaska Local Boundary Commission. The petition shall propose the annexation of the area generally described as:

Beginning at the NE corner of Gustavus Municipal lands (NE corner Sec 3, T40S, R59E CRM); Thence along the N boundary of Sec 2 (T40S, R59E CRM); Thence along the W, N, and E boundaries of Sec 36 (T39S, R59E CRM), to the NW corner of Sec 31 (T39S, R60E CRM); Thence due S to the N shore of Icy Passage; Thence due S across Icy Passage to the Mean High Tide (MHT) line of Pleasant Island; Thence along the MHT meander line along the N shore of Pleasant Island to the Island's westernmost tip; Thence approximately WNW to the SW corner of the Gustavus Municipal Boundary at a point in Icy Strait; Thence approximately ENE along the Gustavus Municipal Boundary through Icy Passage, to the SE corner of the Gustavus Municipal Boundary at a point in Icy Passage; Thence N along the Gustavus Municipal Boundary to the point of origin and containing 18 square miles, more or less with final boundaries to be

determined following public hearings and consultation with the professional staff of the Local Boundary Commission.

Section 2. Petitioner's Representative. That the Mayor or their designee will represent the City for all matters relating to the annexation proceedings.

Section 3. Terms and Conditions. That the annexation will be on the terms contained in the annexation petition developed by the City of Gustavus in consultation with the Local Boundary Commission and approved by the State Legislature.

Section 4. Effective Date. That this resolution shall become effective immediately.


